

# TOWN OF MUNDARE

## Bylaw 864/15

The Council of the Town of Mundare properly assembled enacts as follows:

1. This bylaw is known as "Utility Rates/Penalties"
2. The utility rates/fee/charges are:

### Water Rates

All water rates are per month.

Base rate:

Single residential and commercial	\$ 10.50

Water rate	\$1.95/ m <sup>3</sup> (220 gallons)

Reconnection fee	\$25

If requested, for unoccupied residences, garbage and sewer fees will be suspended till house is occupied. Water fees will still be charged unless the cc valve is shut off.

Truck/bucket fill

**Sewer Charges**

Installation, replacement, repair of sewer service line      Town cost plus 10%

Snaking of sewer service line (minimum of one hour)

- during regular work hours- \$100/2 hours/2 people
  - over 2 hours \$40/person/hour
- after hours-\$200/2 hours/2 people
  - over 2 hours \$50/person/hour

Septic Tank Contractor

-customer outside of Town

\$50/truck  
\$25/ a half truck

-customers inside Town

\$20/truck  
\$10/half truck

**Utility Penalties**

Any utility bill amount outstanding after the date fixed for payment shall incur a penalty of      5%

Any utility invoice amount outstanding after the date fixed for payment shall incur a penalty of      2%

3. The penalties for non-compliance of the utility bylaw are:

Tampering with or disabling a meter/remote the sewer system	10	250.00
Bypassing a water meter	11	500.00
Using water contrary to a restriction or regulation	15	100.00
Operation or interfering with the provision of water services	18	100.00
Interfering with the operation of sewer services	25	100.00
Infraction with no penalty provided		100.00
 <u>Second Offense</u>		
Second of subsequent offence within one year of the original offence	38	2 x original fine
