- a deposit of \$100 (cash, certified cheque, or money order) must be included with the nomination form. The deposit is refunded if you are elected, withdraw within 24 hours of nomination day, or receive votes equal to at least ½ of number of votes of the candidate elected.
- regulations regarding election contributions and expenses are in the candidate guide
- all candidates must file a campaign disclosure form by Thursday, November 2, 2023.
